INTRODUCTION

Who we are

The Consortium, convened by Arigatou International, brings together civil society and faith-based organizations, religious communities, multilateral organizations, academia and individual experts to foster collaboration, share good practises and develop evidence-based and innovative approaches to integrate values-based education and spirituality in early childhood for the protection of children from violence and the promotion of their holistic well-being.

Background

In June 2018, Arigatou International brought together organizations and individual experts working on early childhood development, child protection, education and peacebuilding representing diverse sectors and backgrounds. These organizations and experts came together to form an international consortium to address the spiritual development of children in early childhood for their protection from violence.

Guided by the commitments made in 2017 at the Fifth Forum of the Global Network of Religions for Children (GNRC) by religious and spiritual leaders and organizations working for children, the Consortium was created to strengthen the role of local religious and spiritual communities in offering education in positive parenting and ethical values to help families and children develop empathy, become more resilient, and grow spiritually; as well as to identify and challenge patriarchal structures and practices that perpetuate violence against children, including sexual exploitation, especially of girls.

During its first meeting in Geneva, Switzerland in June 2018, the 20 founding members of the Consortium agreed to work together to contribute to the creation of safe, healthy and loving environments that affirm the dignity of the child, particularly in the early years. They set a vision that has guided our collective work and deliberations during the last four years.

We envision a world where the human dignity of young children is affirmed. Where children live free of violence and they are nurtured by families, caregivers and educators in safe, healthy, respectful and loving environments; where children can develop their innate spirituality and build positive relations with themselves, others and nature, thrive and reach their fullest potential.

The Consortium embarked on the challenging task of developing understanding of the often under-researched and under-invested area of child spirituality, and particularly its important role in the holistic development of children. Going further, the Consortium members envisioned the development of a practical model and approach for addressing the relation between spiritual development, the protection of children from violence and the promotion of their holistic well-being. The members looked at the wisdom and guiding principles found in the major religious and spiritual traditions as well as the scientific evidence on child development and child protection, employing a dialogical approach to address this task.

From 2018 through 2022, members of the Consortium engaged in a collaborative learning process involving numerous activities to foster reflection and advance knowledge on what the spiritual development of children means and requires. In this process, the Consortium benefited from literature reviews, practical work and expertise from its member organizations, scientific evidence on the impact of violence against children, and emerging research on the importance of nurturing children's spiritual well-being and ethical values for their holistic development.

The launch of the Toolkit marked the beginning of a new journey for the Consortium and its members. Four years of development have created a firm foundation for addressing the importance of children's spiritual development in holistic child development programs in the early years and the critical role that religious and spiritual communities play in this task.

A movement is being sown through this Consortium, with strong bonds and collaborations across several sectors, as well as friendships, interfaith collaborations, and new understandings, which is an example of solidarity and what can happen when people join hands for the greater good of the world's children, for their present and for their future.

This Toolkit is an invitation for those who will be using and implementing it to be part of this movement and to continue taking action together to further invest in the spiritual development of children and to address violence against children in all its forms.

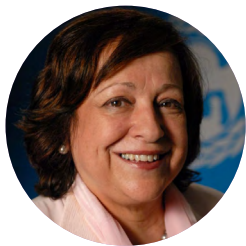

Dr. M'jid, a medical doctor in paediatrics, has over the last three decades devoted her life to the promotion and protection of children's rights. She was Head of the Paediatric Department and Director of the Hay Hassani Mother-Child hospital in Casablanca. Dr. M'jid was a member of the Moroccan National Council on Human Rights and founder of the non-governmental organisation Bayti, the first programme addressing the situation of children living and working in the streets of Morocco.

From 2008 to 2014, she served as United Nations Special Rapporteur on the Sale of Children, Child Prostitution and Child Pornography. Dr. M'jid also worked as an Expert-Consultant for national and international projects, strategies and policies relating to child rights' promotion and protection. She has vast experience in the development of national policies on the protection of the child, and has worked with several governments, non-governmental and inter-governmental organisations.

She also worked as a lecturer in Moroccan and international universities on child rights' protection, promotion, programming and monitoring, as well as social and development policies. A member of several regional and international non-governmental organisations and networks working for children's rights.

Dr. M'jid holds a Doctorate in general medicine from the University of Rabat, a specialization in paediatrics and neonatology from the University of Bordeaux II and a Master of Human Rights from the Human Rights Institute, Geneva. She is the recipient of numerous awards and honours for her strong commitment to protecting the rights of the child.

Dr. Aram served on the 'Experts Committee' of the Government of Tamil Nadu in March 2020 during the COVID-19 pandemic. Over the last two decades, Dr. Aram has also collaborated with the Government of India in making several notable contributions to India's Public Health landscape.

Dr. Aram was invited to serve on the World Economic Forum's Advisory Committee on the Social Determinants of Health Platform. She also serves as Co-Moderator and Executive Committee Member of Religions for Peace-International and is a Board Member and Chairperson of KAICIID. In addition, Dr. Aram serves as the Vice Chair of the Advisory Board of Arigatou International and is a Trustee at the M. S. Swaminathan Research Foundation.

Dr. Aram was awarded the 2021 Leadership Award in Public Health Practice by the Harvard T.H. Chan School of Public Health – making her the first Indian to receive the award. She has been awarded distinctions by each of her alma maters.
